VOLUNTEER ELIGIBILITY Policy

The Discovery Academy of Science Principal will review all offenses to determine the outcome of your Volunteer Status and reserve the right to determine your eligibility status.

- MAY NOT VOLUNTEER IF CONVITED OF any felony sexual related crimes, (including lewd and lascivious crimes) and felony child abuse.
- MAY NOT VOLUNTEER IF CONVICTION WAS WITHIN THE LAST 25 YEARS for felony crimes of violence, felony sale (including trafficking or delivery) of controlled substances.
- MAY NOT VOLUNTEER IF CONVICTION WAS WITHIN THE LAST 10 YEARS for other felony crimes and any misdemeanor crimes of a sexual nature, (including indecent exposure) and misdemeanor crimes related to children.
- MAY NOT VOLUNTEER IF CONVICTION WAS WITHIN THE LAST 5 YEARS for felony theft/economic crimes, misdemeanor crimes of violence (including violation of injunction for protection against domestic violence), misdemeanor drug crimes, misdemeanor crimes involving weapons. Worthless Checks will be considered on a case by case basis.
