We are designated a Florida School of Excellence by FLDOE for the 2022-23 school year. The school is awarded \$91,830 to be distributed to faculty, staff and administrators. Started the new enrollment process as of October 1st, 2022 Link to the current application and lottery process We have organized multiple field trips so far We have a new SSO starting Monday, December 5th so we don't have to overpay PCSO,, for a daily deputy, the daily cost to us is \$567 each school day. All science olympiad studies have begun Mousetrap competition is organized on December 3rd following the board meeting. Working on a weekend FAMILY STEM model Model airplane design Mechanical car designs 3D printing Laster cutting Will need to work with a STEM coordinator - Tuesday to Saturday Organize events and works in coordination with Outreach coordinator

 Mr. Akbaba presented the board updates regarding the new campus. The potential problems are with HVAC delivery dates and electrical equipment which is in back order. The GC is working with the school to find alternative solutions.

Board members reviewed the financial report that are available as of October 2022. Mr. Akbaba assured the board that by looking up the reports the school is not in any financial risk or danger. Since the opening of the school year, there was not a signle school year that the DAS has had a deficit.

Mr. Akbaba worked with Project Financial Advisor Mr. Richard Moreno, the documents allows the debt reserve fund in the amount of nearly \$927K to be invested into triple A rated companies so it can earn nearly \$36K credit toward debt service payment.

The traffic study required by the city of the Clearwater had caused significant delay to the project pushing the completion date to July 24, 2023. It also created additional cost to complete the project nearly \$1.1M. The board asked Mr. Akbaba to seek a financial source for project completion funds. Mr. akbaba is advised to work with FA Richar Moreno and Project Manager, PFDI, Taylor Smith.
