## 1- Call to order

Meeting was called to order by [Chairperson's Name].

### 2- Approval of the agenda items - Action Item

# 3- Approval of 3/25/2023 board meeting minutes - Action Item

The board reviewed the minutes from the last meeting. A motion to approve the minutes was made by Mr. Demir seconded by Dr. Caliskan and the minutes were approved unanimously. Board members also reviewed the minutes of the specially called board meeting in April 3<sup>rd</sup>, 2023. Mr. Demir mentioned how important the meeting was to close the loan. Dr.Nazik moved to approved the April 3<sup>rd</sup> special board meeting minutes. Dr. Caliskan second the motion. The motion passes unanimously.

### 4- Principal remarks

The principal, [Principal's Name], provided remarks about the ongoing initiatives and updates at the school. **Principal's Report for June 24th, 2023, 10am** 

- 23-24 Enrollment update Link, completed the Feb 2023 FTE with 541 students
- SeaPerch Marine Robotics team qualified to attend an international competition at the University of Maryland at Wahington D.C. second year in a row. They ranked 19th in the nation
- Another potential line of income is due to the PCSB error of not sharing the referendum funds between 2016-2020.
  - **<u>Pinellas Primary Charter School</u>** filed a civil lawsuit against PCSB. The initial court ruled in favor of the charter school. They potentially will receive \$3M in funding
  - \$1,738,604 Decision-1: ALL FIVE YEARS
  - \$1,214,791 Decision-2: LAST TWO YEARS

  - Mr. Akba is following the outcome of the case closely and recommended to the board to be on standby for legal action if need be.

#### EDUCATION

• Review of unofficial FSA Scores

The board reviewed the unofficial FSA scores. The comparison between DAS and District Schools was noted. Mr. Akbaba expplained the scores and DAS is statitically significatly higher than distrcit average. DAS is expected to be an A school again this year per Mr. Akbaba's calculations. MR. Akbaba mentioned the data based decision making process and the strong MTSS implementation.

### • Nursery Campus Updates

- DAS Dunedin Campus updates for August 2025:
  - The board was informed about the preliminary meeting with the city.
  - A public hearing regarding a new three-story building within 300 ft of the property was announced.
  - The City of Dunedin will vote on the hearing. The hearing date is pending the school's negotiatons with the St. Mark Lutheran Church's council.

- Approval of Budget Amendment #2 was discussed and approved unanimously by the board. Mr. Akbaba explained the additional incomes
- 2023-24 Budget was presented and discussed in detail Mr. Demir moved to approve the budget, Dr. Nazik seconded the motion, the motion passes unanimously.

## • ERTC Tax Credit

- The board held a discussion and review of the ERTC Tax Credit.
- Preliminary agreement was presented for approval
- Jorns & Associates, CPA FIRM was introduced as a new vendor to process ERTC for the school. It was noted that current dealings with the business were not looking great.
- Mr. Demir inquired the validity of the Jorns & Associates, CPA FIRM Dr. Caliskan and Dr. Nazik inquired about the potential loss of the school. The school administration spent \$2,600 as of June 23<sup>rd</sup> and the funds are refundable within 30 days. The school can get its \$2600 due to the engagement with the Jorns & Associates, CPA FIRM. Board move to approve the engagement letter presented, Dr. Nazik seconded, the motion approved unanimously.

#### **PERSONNEL:**

- Contract Renewal for Mr. Akbaba
  - The board discussed the contract renewal for Mr. Akbaba, including:
    - The CPI Index from the US. Dept of Labor for Tampa-St. Pete-Clearwater Area was at 11% [link attached].
    - Reasons for salary increase were presented, highlighting:
      - School's financial stability
      - School's academic success
      - Increasing enrollment trend over the past 10 years.
    - Reference was made to the American Association of School Administrators Annual Study [link attached].
    - A request was made for Mr. Akbaba's salary to be in the 75% to 99% range, with details provided.
  - The board decided to increase Mr. Akbaba' base salary only %15. Further increases or any bonuses will be discussed with the school Attorney Melissa Arnold then be presented to the board for review. Mr. Demir moved the approve the contract Dr. Caliskan second the motion. The motion passed unanimously.
